- 2. Earline Cox has filed an Application for Substitution of Personal Representative with the District Court that has been granted by an Order appointing Tammy Kennedy as Personal Representative of August Kennedy's estate. (See Exhibit "A")
- 3. It is necessary for the Plaintiff, now Tammy Kennedy on behalf of her daughter's estate, to amend her Petition to reflect that she is the proper Plaintiff.
- 4.
